Red Wing Restyle & Pre-Loved Tootsie Too's (The Store) will determine the price of your items and you will paid the following percentages of the selling price: Selling prices of \$0-\$49.99 - 40% paid, \$50+ - 50% paid. Items will be accepted and priced at the discretion of The Store. All estimates of selling values are opinions and are not guaranteed to sell at that price. There is a \$1 store fee added to each consigned item.

Most items are available for purchase for 60 days after being processed. Large items such as baby equipment will be available for 30 days after being processed. Ownership of the items is retained by the consignor during the initial period and are left at the risk of consignor. The Store assumes no liability for fire, flood, theft, loss, or damage of merchandise. After the initial consignment period, consigned items become property of The Store to dispose of at our discretion. Consignors may pick up unsold items at anytime during the contracted period, it is the responsibility of the consignor to track dates and find the items in the store.

Consignors living within 30 miles of the store are required to receive their account balance in person. Cash payments will be made in store during normal business hours. Consignors who live or move outside the 30 mile radius can request a check to be mailed; there will be a \$2 fee deducted from payment amount. Checks must be requested and will be issued one time mid-month. Consignors are responsible for their items, account information, activity/inactivity, account balance, and requesting payouts.

Consignors may use their account balance to make in-store purchases.

After 1 year of inactivity, any unsold inventory or remaining account balance will become property of The Store. 'Activity' includes selling an item, taking a payout, or using account credit.

The Store will have periodic sales at its discretion; any merchandise in stock at that time is subject to the sale price.

The Store will only accept clothing that is name brand, odor neutral, clean, damage free, wrinkle free, and pet hair free. If The Store needs to spend excessive time steaming, ironing, mending or cleaning we will charge an additional fee against the item when it is entered into the computer, if item(s) is accepted. The Store reserves the right to store off-season inventory for the consignors without access permissions.

Items will be inspected twice, once upon intake, and again when processed and priced. The Store may find missed stains, damage, unwanted brands, etc. after the initial inspection, items will then be deemed not sellable, and items will automatically be rejected and donated. If the Consignor requests rejected items to be returned, items need to be picked up within 2 businesses days of being contacted or they will be donated.

After 1 year of inactivity, any unsold inventory or remaining account balance will become property of The Store. 'Activity' includes selling an item, taking a payout, or using account credit.

Consignors are responsible for updating account contact information.
